- The School concerned will follow the terms and conditions as laid down in the "Assam Non- Govt. Educational Instituitions (Regulation & Management) Act, 2006" as amended in 2018 and the "Assam Non-Govt. Educational Institutions (Regulation & Management) Rule, 2007" therein accordingly.
- 2. In case any anomaly is detected at any stage in respect of land documents, School building, reserved fund and other criteria, then the concerned school shall be disqualified from obtaining NOC affiliation under CBSE / ICSE and the NOC already issued to the School shall be revoked.
- 3. The Schools which are granted NOC for fresh affiliation to CBSE / ICSE course shall establish linkage with Fee Regulatory Committee for fixation of fee structure.
- 4. Only the fresh registration of students will be allowed to register under CBSE / ICSE.
